Dear Shareholder,

We are writing to you in relation to a notice issued to you on 19 June 2023 ("**Earlier Notice**"), relating to certain changes to the Manulife Global Fund (the "**Company**").

Words and phrases used in this Notice shall, unless otherwise provided, have the same meanings as are ascribed to them in the Earlier Notice.

The Earlier Notice notified you of certain benchmark changes and/or clarifications with effect from 1 August 2023 (the "Effective Date"). In particular, the Earlier Notice specified that the name of the existing performance comparison benchmark of Taiwan Equity Fund will be updated from the TSEC TAIEX index to the TSEC TAIEX PR TWD index. You are receiving this Notice because you are an investor of Taiwan Equity Fund.

We would like to take this opportunity to clarify that, with effect from the Effective Date, the name of the performance comparison benchmark of Taiwan Equity Fund will be TSEC TAIEX <u>TR</u> TWD index as opposed to TSEC TAIEX PR TWD index. As such, the details relating to Taiwan Equity Fund set out in the Earlier Notice should be amended as follows:-

Taiwan Equity Fund	TSEC TAIEX index	TSEC TAIEX <u>TR</u> PR TWD index

For the avoidance of doubt, the above correction aims at correctly reflecting the name of the existing performance comparison benchmark of Taiwan Equity Fund, and there is no actual change to the benchmark adopted by the Sub-Fund.
